STEPS TO TAKE TO ENROLL IN 10% CREDIT

(course must be completed by 12/31/2021 in order to be eligible):

1. If Your Practice Is Already Insured with Physicians Insurance:

- Practice is automatically eligible to receive this credit and will receive communication direct from Physicians Insurance.
- Each physician must take (1) hour of continuing education from one of the approved EHN Risk Management courses in order to qualify for credit (www.phyins.com/ehn).
- **Early completion is HIGHLY encouraged! If your course is completed by 09/30/2021, then the credit will apply at your next renewal. If the course is completed after 09/30/2021 and before 12/31/2021, then the credit will be applied to your account no later than 03/31/2022.**
- The credit is only applied to those physicians who complete the required course.
- Physicians must be contracted with EHN and must be a Washington State provider
- Credit will be applied to the next renewal after completion of the required continuing education.
